1. Call to Order:

a. B. Butterly called the meeting to order at 9:04 AM

Project Understanding - Waterman Blvd Pedestrian Street Lighting



Waterman Blvd between Debaliviere Ave and Belt Ave is a minor collector street that serves as a link to collector streets and serves local residential neighborhoods. The project is two blocks long starting at the intersection of Belt on the east and ending at Debaliviere on the west. It is a two-way street with curb side parking on both sides, serving residents. Streetlights are provided along the street consisting of standard streetlight fixtures on metal poles. The neighborhood would benefit immensely with the installation of new pedestrian scale lighting along both sides of the street to supplement the existing streetlights. The pedestrian lights can be installed in the tree rows on each side of the street like the recently installed pedestrian streetlights on Pershing Avenue.

The photo at the left shows an example of the city's standard acorn light on a decorative concrete pole. This light is typical of most of the newer pedestrian scale lights installed throughout the Central West End. We would specify the same pole and light as we specified for the Pershing Avenue Pedestrian Lighting project.

ABNA understands the project area has multiple utilities, several entrances for residence accesses, and some large trees which must be considered during the design planning for the new pedestrian scale lights and during the construction stage. The existing underground utility locations will be marked prior to completing the field survey

so the locations can be included in the plans. During the design phase of this project, we will meet with the St. Louis City Lighting Department, as we did on our recently completed **Pershing Avenue Pedestrian Streetlights** and **Laclede Avenue Pedestrian Streetlights** projects, to determine the capacity of the existing lighting substation to power the new lights. In the event there is insufficient capacity to add the additional electrical load, we will work with the City to determine the best location for a new substation.

The design of the pedestrian lighting will be based on guidelines for pedestrian lighting contained in the Illuminating Engineering Society Handbooks RP-8, *Roadway Lighting* and G-1, *Security Lighting for People, Property, and Public Spaces.* ABNA will provide photometrics for the proposed lighting utilizing Lighting Analysts, Inc. AGi32 design software

Project Team

Project management and lighting design will be led by **Franklin Eppert PE**. Frank is a resident of the Central West End Community and has over 40 years of electrical engineering design experience. He has prepared lighting studies and construction documents for a wide variety of roadway projects including recent lighting expertise provided to the CWE SE Neighborhood for the West Pine and Laclede Avenue lighting and the Debaliviere Place Special Business District for the Pershing Avenue Lighting. Frank's studies have included evaluations of roadway photometrics and performance as governed by the Illuminating Engineering Society's (IES) Roadway Lighting Guidelines. 
